RISKS AND DANGERS

- Possible injury sustained making crafts using scissors, hot glue guns, wire (e.g. burns, cuts, eye injuries, pokes).
- Possible discomfort sustained from using spray paints, sealers (e.g. headache, nausea, skin irritation).
- Possible injury sustained operating or working with objects which involve propulsion or movement (e.g. breaks, bruises, cuts, eye injury, scrapes).
- Possible exposure to the Covid-19 virus. NWP Summer Camps will make every effort to provide a safe environment for participants and will follow the guidance as set out by Alberta Health Services.

Assumption of Risks: I expressly and voluntarily consent and agree to assume full responsibility for any and all damages or injury that may arise out of or result from the Child's participation in NWP Summer Camps.

Release of Liability: I release, waive and forever discharge Northwestern Polytechnic ("NWP"), its affiliates, their governors, officers, employees, personnel, volunteers, and any of their staff members, instructors, agents or representatives ("Releasees"), from all liability to me, the Child, and our respective legal representatives, heirs and assigns and any person claiming through or under myself or the Child, of and from any and all present and future claims, demands, damages, actions, or rights of action, whether legal or in equity, arising from or by reason of any bodily injury or personal injuries known or unknown, death, loss or theft of personal property or property damage that may occur as a result of the Child's participation in NWP Summer Camps.

I further release, waive and forever discharge Releasees from all liability to me and the Child, and our respective legal representatives, heirs and assigns, of and from any and all present and future claims, demands, damages, actions, or rights of action, whether legal or in equity, arising from or by reason of any bodily injury or personal injuries known or unknown, death, loss or theft of personal property or property damage that may occur in, on or about NWP's premises or the premises of the Summer Camps, or as a result of the Child's participation in NWP Summer Camps.

I further release the Releasees from any claim whatsoever on account of first aid treatment, medical services or other services rendered to the Child during his or her participation in NWP Summer Camps.

PICK UP AND DROP OFF

Please drop off your child between 8:00 a.m. and 8:15 a.m. so that they have time to ready themselves for an 8:30 a.m. start time. Children must be signed in by a Parent or Guardian every day. Children are to be picked up between 4:00 p.m. and 4:30 p.m. and must be signed out by a Parent or Guardian, unless permission has been given for the child to sign themselves out.

****PLEASE NOTE:** Staff will NOT be available prior to 8:00 a.m. or after 4:30 p.m. Please make the accommodations required to ensure your child is not left at NWP unsupervised.

Parents will be notified if their child's behavior is inappropriate. If the inappropriate behavior continues, NWP reserves the right to remove the child from camp, without a refund.

REFUND POLICY

Parents may withdraw their children from a camp by advising NWP Fine Arts Conservatory by phone, email, or in person. Full refunds will be given if the request to withdraw is made at least five business days before the camp start date. Requests made less than five business days before the camp start date, but prior to the camp start date, will be refunded 50% of the registration fee. No refunds are given after the camp start date. No refund is given for any days missed in a camp.

WHAT TO BRING TO CAMP

Please have your child bring a lunch and snacks to camp. Due to allergies, please do not include peanut butter, other nut butters or nut snacks. Be sure to make note of allergies or a special diet in the Medical Information section of this form. Campers should dress in weather appropriate play clothes and should bring a hat, running shoes, sun block, bug spray, and a water bottle. Make sure you label your belongings so there are not any accidental mix-ups!
