### **CALENDAR DESCRIPTION:**

A 30 hour observation course in which student teachers are assigned to a working teacher in a classroom setting. This course is intended to supplement the practicum experience offered in ED2510.

**PREREQUISITE(S)/COREQUISITE:** No credit is issued with this course as credits have already been received for ED2510. This course adds 30 additional hours to fulfill the transfer requirements for students transferring to the Faculty of Education at the University of Lethbridge.

## **REQUIRED TEXT/RESOURCE MATERIALS:**

- Police Information Check **AND** Child Intervention Record Check (both need to be submitted to your ED2520 instructor prior to beginning your first classroom observation)

## **DELIVERY MODE(S):**

Field placement only.

## **COURSE OBJECTIVES:**

#### **Field Experience**

The Field Experience Observation opportunities consist of **TWO five-week rounds** of school visits, one in an elementary school setting and one in a secondary school setting.

During **each round**, **ED2520 students** will spend a **minimum of 15 instructional hours** at an assigned school after contacting the Mentor teacher in the first week of each practicum to establish an observation schedule. During each round ED2520 students will spend the equivalent five (5) half days at an assigned school; Note: A half-day is generally considered to be three (3) Instructional Hours. Observation hours are based on Instructional Hours.

## **TRANSFERABILITY:**

## This course is considered a University Transferable Course; however, the student has the final responsibility for ensuring the transferability of this course to Alberta Colleges and Universities.

## **GRADING CRITERIA:**

## To complete ED2520, students must:

- 1. Students must successfully complete **both** placements of the field experience, as evidenced by handing in a timesheet signed by each mentor teacher attesting to the successful completion of required practicum hours.
- 2. Students must submit their Observation journal, report and documents by the date set by the instructor and achieve an overall grade of at least 75% (B).
