**DELIVERY MODE(S):** The course work includes lecture, class discussion, in-class quizzes, and written assignments

**COURSE OBJECTIVES:** This course offers a survey of twentieth- and twenty-first century writings from around the world. Its aim is not to discuss contemporary global literatures in their totality; instead, this course is designed to allow us to perceive the richness and variety of international writing. At the same time, we will learn how literature makes connections across geographical, cultural, and historical distances.

**LEARNING OUTCOMES**: After taking this course, the successfully participating students will demonstrate the following:

- Knowledge of, and the ability to use, a critical vocabulary suited to the discussion of literature
- The ability to discuss the interrelation of text and context in the production and consumption of literary texts
- Skills crucial to effective college-level essay composition, from planning, to writing, to revision
- The ability to perform secondary research as well as the ability to use research effectively and responsibly in writing assignments

#### **COURSE SCHEDULE/TENTATIVE TIMELINE:**

Week 1: Introduction to the course

Weeks 2-5: Early 20<sup>th</sup>-century literature: modernity, absurdity, and alienation

Weeks 6-10: Mid-century writing: history, memory, postcolonialism

Weeks 11-15: The late 20<sup>th</sup> century and beyond: postmodernism, diaspora, globalization

# STUDENT RESPONSIBILITIES:

1. Written assignments are to be uploaded to MyClass (D2L). Students must accept the Turnitin agreement to submit written work.

- 2. Written assignments are to be submitted *on time*. Late assignments will incur a penalty of **5%** per day, with weekends counting as two days.
- 3. Extensions will not be granted for written assignments except in extenuating circumstances. Documentation will be required.
- 4. We are currently living through a pandemic, so your first priorities should be to look after your own health and the health of the people around you. My expectation is that students who are healthy will attend all classes; however, students who exhibit symptoms should contact me to let me know they're ill and will be absent because of it. Excused absences will have no impact on a student's grade. However, unexcused absences will negatively affect the participation component of a student's grade and could result in a failing grade for that component of a student's final mark.
- 5. Students are required to check MyClass before each class to stay informed concerning the schedule of readings as well as course updates and announcements.
- 6. Students wishing to see me during office hours **must** wear a mask. Students who do not want to wear masks have the option of meeting with me via Zoom.
- 7. Cellphones should be out of sight during class time. Students who are repeatedly on their cellphones during class will receive failing grades for participation.

- 8. The midterm will take place on October 28 and it will not be rescheduled except in extenuating circumstances. All high-flex students must write the midterm in person. All V.C. students are responsible for arranging supervision at an approved testing center; alternatively, VC students may write the midterm under my direct supervision here in Grande Prairie. Documentation will be required for any student wishing to write the midterm on an alternate date.
- 9. Students should feel free to email me with questions or concerns at any point during the semester. I will do my best to respond to your emails as quickly as possible, but students should anticipate a 24-48 hour delay (depending on which day, the time of the day, what stage of the semester we're in, etc.).
- 10. Students in this high-flex course should feel free to attend in person or remotely. Students attending remotely must have their cameras on to be counted as present.
- 11. The final exam for this class will be scheduled by the registrar and will take place in December. The exam will not be rescheduled except in extenuating circumstances. All high-flex students must write the final exam in person. All V.C. students are responsible for arranging supervision at an approved testing center; alternatively, VC students may write the final exam under my direct supervision here in Grande Prairie. Documentation will be required for any student wishing to write the final exam on an alternate date.
