**CALENDAR DESCRIPTION:** An historical survey of music from the Baroque period (1600-1750) through to the music of the early part of the Romantic period (1850). Students will concentrate on the various styles and genres of the periods under study. They will further develop skills of aural recognition, writing, research methods, and correct bibliographic practices.

# **DELIVERY MODE(S):** Remote Lecture

**COURSE OBJECTIVES:** The purpose of the course is to provide an overview of the period of music history from 1600 to 1850 in terms of the evolution of musical style and its social and political context. The study of Western European music history will begin with the Baroque Period and the development of opera and continue through the music of the Classic and Romantic Periods.

**LEARNING OUTCOMES:** Included in the study of this time period is research techniques, formatting, and term paper writing. The other aspects include: (a) analyzing the forms of the Baroque Classic and Romantic periods; (b) identifying pieces of music aurally; (c) expressing verbally the specific trends of each historical time period including relationships between political and music history; (d) comparing and contrasting the varying styles of the period; and (e) expressing, through the streaming approach to history, the dates and developments of music in Italy, France, Germany, England, Spain, Russia and the New World. At the end of the course, students will be able to identify both aurally and in written form the music history eras and styles covered by this time period.
