
## CALENDAR DESCRIPTION

This course is an introduction to the study of how individuals view and affect one another in a social context. Topics covered include persuasion, prejudice, behaviour and attitudes, conformity, altruism, group influence and attraction

# **DELIVERY MODE(S):**

Lectures will be delivered remotely via Zoom. The Zoom link for this course is posted on the course homepage of myClass. Students will attend lectures via zoom. Students will complete chapter assignments, engage in online discussions, access all exams and submit assignments via myClass.

# **COURSE OBJECTIVES:**

This course is designed to provide students with a foundation in the knowledge of social psychology. The course is based on a scientific approach to social psychology. While it provides a survey of the whole field, it also highlights the centers of current action such as social cognition, and the application of social psychology.

## **LEARNING OUTCOMES**

- In this course, students will demonstrate fundamental knowledge and comprehension
  of major concepts, theoretical perspectives and empirical findings in the topical areas
  of social psychology, including social beliefs and attitudes, the relationship between
  attitudes and behavior, persuasion, conformity, obedience, group influences, altruism,
  aggression, attraction and prejudice
- discuss how principles discussed in these areas enable the understanding of social behavior
- incorporate sociocultural factors in their explanations of social behavior
- demonstrate basic level understanding of various research methods used in scientific investigations of psychological phenomena
- apply their knowledge of basic research methodology to critically evaluate psychological research and write an integrative research paper

PLEASE NOTE: In order to preserve an evaluation system that is fair to ALL students, requests for additional/substitute work will NOT be granted to students wishing to compensate for poor grades on assignments, guizzes, midterm exam or final exam.

NOTE REGARDING EXAMINATIONS: Students might be expected to take examinations [quizzes, midterm and final examination] online with the use of Respondus Lockdown Browser and Respondus Monitor exam prFEBoring software. The instructor's decision to use Respondus will depend upon student compliance to the instructor's examination expectations. These expectations are that for the full duration of all examinations, students: (1) have their cameras on, (2) are in full view of the camera (not just the forehead!), (3) are zoomed in during the examination, (4) are not accessing other devices during the examination, (5) have other materials put away and out of site during the examinations, and of course (6) are not cheating.

If the instructor determines that it is necessary to use Respondus Lockdown Browser and Respondus Monitor, students must download both programs on the device used to take the examinations. Lockdown Browser and Respondus Monitor be on the myClass platform. The prFEBoring software is a requirement to uphold academic integrity and is necessary to meet accreditation requirements. Lockdown Browser and Respondus Monitor requires Windows or Mac desktop, laptop, or iPad platforms. Chromebooks, smart phones, and other tablets are not supported. If you do not have access to a Windows or Mac desktop, laptop or iPad, you can book a College PC via the GPRC App -> On-campus Reservations. It is important to note that the software recordings are automated systems and are designed to be less intrusive than in-person prFEBors. The software is only running while you are signed in during your exam. The exam administrators only review the recordings after the exam is submitted and only if it was flagged due to suspicious activity. The collection and use of your personal information is in accordance with the Freedom of Information and Protection of Privacy (FOIP) Act S. 33 (c) which states that "No personal information may be collected by or for a public body unless that information relates directly to and is necessary for an operating program or activity of the public body." In addition S. 39 (4) states, "A public body may use personal information only to the extent necessary to enable the public body to carry out its purpose in a reasonable manner." If you are unable to complete your [quizzes/examinations] using the prFEBoring software you may request alternative accommodations to the online testing by contacting your instructor and the GPRC Testing Centre by telephone at 780-539-2212 to arrange to write your exam. Students must book their [quizzes/examinations] no less than 2-weeks in advance of the test date and students are choosing to write the [quizzes/examination] in the GPRC Testing Centre are responsible for the \$30 sitting fee.

- <u>Quizzes:</u> There will be four multiple choice quizzes based on material covered in both the textbook and the lectures. Each quiz is worth 5%, for a course total of 20%. These quizzes will be written online via myClass during class time (dates are posted on page 6 of this outline). If the APRision is to use Zoom rather than Respondus, students must be connected to Zoom during these quizzes. Students who are not connected via zoom during the quizzes will be assigned a grade of 0 (zero) for that quiz. Please refer to page 8 of this course outline for more information on missed quizzes.
- Midterm and Final Exams: The midterm and final exams will include multiple-choice questions based on material covered in both the textbook and the lectures. The final exam will NOT be cumulative; it will cover material from the class immediately after the midterm to the end of term. If Respondus is not being used, you must be connected to Zoom during the midterm and final exam. Students who are not connected via zoom during the exams will be assigned a grade of 0 (zero) for those exams. Please refer to pages 8 of this outline for more information on missing the midterm exam and/or final exam.
- 3. Participation/Attendance: Student input during lectures is enthusiastically welcomed and strongly encouraged. Attendance will be taken every class (Zoom records attendance). Please ensure that your full first name and last name is associated with the device that you use for zoom. Attendance may be taken more than once during a class period. Please note that in my courses, students who miss more than 10% of classes without an acceptable excuse may be debarred from writing the final exam.
- 4. Online Discussions: Various discussion questions will be posted on myClass. Grades will be based on whether the student's posts move the discussion forward and on the quality of evidence students provide to back up their response to each discussion question. Information cannot be copied and pasted from other sources (see note on plagiarism on the last page of this outline). Students are expected to contribute to these discussions by posting new threads and replying to other students' threads.

Each discussion question is graded out of 5 points; to attain full marks for this component of the overall grade, students need to accumulate 25 points (minimum participation on 5 discussions). Students may participate in more than 5 discussions.

- <u>5.</u> <u>Chapter Assignments.</u> There will be 12 multiple choice chapter assignments, each comprised of questions taken from the test bank of the textbook. Your marks across all the assignments will be averaged; the average mark of all the assignments is worth 10% of your overall grade. These assignments will be posted on myClass and you will answer the questions on myClass. Deadlines for each assignment is included on this course outline (page 4).
- **<u>6. Annotated Bibliography.</u>** Details of this assignment are provided on myClass course home page.

## STUDENT RESPONSIBILITIES:



The college calendar has information regarding the conduct expected of students. Here are the expectations specifically for my classes:

1. TALK TO ME IF YOU HAVE CONCERNS OR YOU ARE EXPERIENCING DIFFICULTIES THAT MAY HAVE NEGATIVE IMPACT ON YOUR ACADEMIC PERFORMANCE. These concerns may include personal challenges or class-related issues (e.g., difficulty with material, disruptions from other students). Please know that I will keep your concerns confidential.

**EXAM ACCOMODATIONS**: Exam accommodations are used by any number of students whose learning disabilities affect processing and comprehending printed material, learning, and/or concentration (either due to the condition itself, or the effects of the medication which is used to treat the condition). ## 2. **ZOOM EXPECTATIONS**

- A camera and microphone are mandatory; the camera must be kept on during the lectures, but the microphone should be on mute except when you wish to speak up (i.e., ask questions or make comments relevant to the lecture/class discussions).
- Your name must be displayed with your image.
- The chat feature in Zoom is to be limited to questions to the instructor or supportive comments to students-it is NOT a place to have a general text chat.
- Although lectures will be recorded, each recording will be made available ONLY to students who remotely attend the lecture at the scheduled class time (and wish to review the lecture) and to students who have an excused absence for a particular lecture.
- Students are expected to exhibit respectful behavior to the instructor, guest speakers and other students. We will discuss topics in class that may cause disagreement. It is expected that all participants will deal with such disagreements WITHOUT resorting to behaviors/comments that are dismissive, demeaning or threatening to others. Swearing and use of slurs against individuals or groups (racial, religious, gender, etc.) are unacceptable. Students unable to meet these expectations will be required to leave the class in the interest of preserving the learning opportunities of other students. Please refer to the GPRC calendar for more information regarding student conduct.

# 3. ATTEND CLASS (ZOOM LECTURES) AT THE SCHEDULED CLASS TIMES:



This term, all lectures will be delivered remotely at the scheduled class times via Zoom; students are expected to attend lectures at the scheduled class times via Zoom. Attendance will be taken every class and may be taken more than once each class.

<u>Missed Lecture Material</u>: Although notes are available on myClass, they are not complete; attendance is required to get full lecture information. If you miss a class, you are to obtain missed material by approaching a classmate, <u>not</u> the instructor. It would be <u>unfair</u> for students who miss lectures to be advantaged by getting the instructor's notes.

Missed Quizzes/Exams: Dates for the quizzes and midterm are included on page 4 of this course outline. Missed quizzes will generally <u>not</u> be rescheduled. If you miss a quiz due to verified illness, dentistry, accident, emergency, or GPRC obligations (e.g., you are away due to the requirements of another course) the weight of the quiz will be transferred; missed Quiz 1 or 2 will be transferred to the midterm exam, missed Quiz 3 or 4 will be transferred to the final exam. Quizzes missed for reasons that do not include verified illness, dentistry, accident, or emergency, will be assigned a "0" (zero). Holidays, employment, etc. are NOT considered to be excusable reasons to miss any exam in this course. Furthermore, quizzes missed without explanation from the student will assigned "0".

According to GPRC policy, deferring a missed Midterm Exam is at the discretion of the instructor. In my courses, students who miss a midterm because of illness, dentistry, accident, or emergency (verified) may write the midterm at a later date (set by me—I will choose a date that is mutually convenient for me and the student). When students miss the midterm for reasons that do not include verified illness, dentistry, accident, or emergency, a "0" is assigned to that the midterm. Students who miss the midterm without explanation will receive a "0" on the midterm. Absences from a registrar-scheduled Final Exam fall under GPRC Examination Policy. It is the responsibility of the student to be informed about these policies prior to the final examination period.

If you miss the final exam due to illness, you will be required to submit an application to the Registrar's office for permission to write a deferred exam and must do so within 48 hours of the scheduled exam time. You may defer the final exam for up to 20 days of the end of the examination period. You will be required to provide documentation for your illness.



## 4. LEARN & RECORD ASSIGNMENT DEADLINES AND EXAMINATION DATES/TIMES

These dates are posted on this course outline and on myClass. You can set the notifications on myClass to remind you of upcoming assignment deadlines and exams. For the sake of fairness for ALL students, assignment deadlines will NOT be extended for those who miss an assignment. If you know that you will be away when an assignment is due, it is expected that you hand in that assignment earlier than the announced/posted date. FYI—myClass chapter assignments can started/completed before the announced/posted deadlines.



#### 5. OUT-OF-CLASS WORK

Students are expected to prepare for each lecture by reading the assigned chapters and lecture notes that are posted in advance. Although all information in the textbook is important and interesting, limited class time prevents discussion of all the material covered in the assigned chapters. You are responsible for learning the material covered in the assigned chapters, including material that is not discussed in class.
