CALENDAR DESCRIPTION:

Students will examine the developmental, cognitive, biological, and behavioural processes involved in the development of various psychological disorders of children and adolescents with emphasis on causality, assessment, and treatment.

COURSE OBJECTIVES:

As a result of taking this course, students will gain the abilities to define, explain, demonstrate, evaluate, and articulate:

- the major theories, perspectives and concepts in the causes of psychological disorders of children and adolescents,
- the process of cognitive, social, and emotional factors and their impact on the development and the treatment of the various disorders,
- the role of the biology and the environment in the causality, sustainability, and treatment of psychological disorders,

- the process of diagnosis and the advantages and the concerns associated with diagnosis and labeling,
- the symptoms associated with each disorder based on the DSM-5 criteria and behavioral/research models of diagnosis, and
- the process of formal and informal psychological assessment of children and adolescents.

LEARNING OUTCOMES:

- Identify the various research methods for studying and understanding child and adolescent psychopathology.
- Describe major concepts and theoretical perspectives in the causes of psychological disorders of children and adolescents.
- Identify and describe the symptoms associated with each disorder based on the DSM-5 criteria and behavioral/research models of diagnosis.
- Summarize the process of diagnosis and associated concerns.
- Identify and describe how cognitive, social, and emotional factors impact the development and the treatment of the various disorders.
- Explain the role of the biology and the environment in the causality, sustainability, and treatment of psychological disorders.
- Explain formal and informal assessment strategies used in the psychological assessment of children and adolescents.
