2.3 GPRC Fairview Land, Utilities Right of Way

In accordance with the Post-Secondary Learning Act, the Board shall not without prior approval of the Lieutenant Governor in Council, sell or exchange any interest in land that is held by and being used for the purposes of the Board.

Grande Prairie Regional College has received a request for an easement on its property: SW/SE 34-81-3-W6. College land is requested by ATCO Gas and Pipelines Ltd. to construct, operate and maintain a low pressure distribution gas pipeline.

The properties mentioned are free and clear of encumbrances, and in the event the Order in Council is not received by the College, the request for easement is void.

MOVED by Tab Pollock, **seconded** by Anita Luck, the Grande Prairie Regional College Board of Governors approves an agreement to permit a strip of College land comprising of 3.434 acres for the right-of-way and 1.621 acres for the working space on the North and East perimeters of the legal land described as SE34-81-3-W6 be utilized by ATCO Gas and Pipelines Ltd. as a permanent right-of-way.
